Westover Street Paving Project

Hampden Township will be paving streets in the Village of Westover during the fall of 2007. Jerry Spease, the Hampden Township engineer, indicated all work should be completed by the end of October, 2007.

The plans are to pave from the cul-de-sac and the end of Stephens Crossing to Bracken Court,

Bracken Court to Nicholson Court, Nicholson Court to Westover Drive, Westover Drive to 6320 Stephens Crossing, and all of Westover Drive in the original section of Westover. Here is a map of the work to be done on the right. Thanks to Hampden Township for the street maintenance.



Westover Reaches Final Construction Phase

Bill Keeley, Westover developer and builder, gave us a preview of his new Townhouse community called Jamestown Square. It will be located behind the old airport hanger off Westover Drive and the units will not be facing Skyport Road. There are 38 condominium style homes and they will range from 2,200 to 3,200 square feet, will look somewhat like the current Devonshire Square property, have basements, be all gas, and have a larger first floor footprint. The larger footprint will accommodate a large kitchen area and expanded length between the garage and house to accommodate a larger garden area or a first floor master bedroom suite.

This is the final phase of the Westover Community. Bill indicated it will be sad, but the airport hanger must go!!!

Sergeant Shissler tells us that operation Smooth Operator is proceeding on schedule. What is Smooth Operator? This is a regional non-profit program with Maryland, DC, Virginia and parts of Pennsylvania that work together to stem aggressive driving. Hampden Township fully participates in the program and the Carlisle Pike was selected for the program based on recent crash data. There have been over 62,000 citations issued (not just in Hampden Township, but throughout the whole program). Street Light Updates


The relighting project within Westover is completed with all of the lights upgraded to three times the luminance level as the previous lights resulting in the use of less electricity!!!

New Community Post Office Now Open

Hampden Township, the largest municipality in Cumberland County, still does not have its own Post Office, but a USPS Contract Unit is now open to serve the area. Tucked inside the Sunoco Mini Market located at 6025 Carlisle Pike, the Contract Unit is open Monday-Friday from 9 am to 6 pm, and Saturdays from 10 am to 4 pm. Mail collection times



The Contract Unit offers most of the services as a full-scale Post Office does, including domestic and international mailings, stamps, expedited service, insured, certified, return receipt and COD mail.

Like the service station and mini-mart, the Contract Unit is operated by Khalid Mughal. Dr. Mughal is a native of Lahore, Pakistan, who was educated in Pakistan, Thailand, and New Zealand, where he earned his Ph.D in biotechnology. After working for a number of years for Intralytix in Baltimore, he settled in this area to fulfill his dream of owning and operating his own business.


You're Invited: Haunted House Thursday October 25th Trick-or-Treat Night
